^{**}Prizes: For speed classes (A and B), ribbons for 1st-6th place will be given out. For jackpot classes (C), 75% of the total entry fees collected will be paid out at the rate of 50% for 1st place, 30% for 2nd place and 20% for 3rd place; rounding up or down depending upon the amount of change. Winnings will be <u>credited towards any open show bill</u> and any remaining moneys will be paid out in cash.



- ***TIP Awards will be given out for two heights: 2'3" and below and 2'6" and above. Be sure to register your eligible off the track thoroughbred at www.tjctip.com to participate.
- 1. You MUST pre-enter by noon on Friday, the day before the show. Entry is <u>not complete and contestant numbers will NOT issue until</u> the signed entry form, signed waiver, payment (including an open check when checking in), and current negative coggins/info are RECEIVED. A current negative coggins is required to enter premises.
- 2. A separate entry form is required for each horse and rider combination. Office fee is required for each entry. Medic Fee is per rider only.
- 3. There is a \$5.00 convenience fee for the use of PayPal for each transaction, whether a payment or a refund. Paypal to ssbc1948@gmail.com
- 4. Proper tack and dress is required, including boots & ATSM rated helmet. No dressage whips are permitted. Each rider must wear a number.
- 5. Email entries by the Sunday immediately prior to the show, register for and show in a minimum of two A and B classes and receive a \$10 pre-entry credit.
- 6. When a class starts and your number is called, you have 3 (three) minutes to enter the arena. If you do not enter, you go to the end of the line unless you were the last rider, then you forfeit your round and are still responsible for payment.
- 7. If scratching, you must scratch prior to the height change for the class in which you are riding, otherwise you will still be responsible for payment.
- 8. For JACKPOT classes, you must ride at least 1 other class at the height of the jackpot jumper round you are riding.
- 9. For JACKPOT classes, you may ONLY ride 2 jackpot rounds PER SHOW and they must be at two consecutive heights, i.e., if you ride the 18" jackpot round, you can ride the 2'-2'3" round, but no higher jackpot round. You can ride higher A and B classes.
- 10. Everyone renting a stall must pay the \$10 stall cleaning fee for each stall rented, whether for a horse or a tack stall. SSBC members may not use work certificates to pay that fee.
- 11. Judge's and show manager's decisions are final.
- 12. There is NO SCHOOLING, mounted or in hand, IN THE COVERED ARENA at any time, NO EXCEPTIONS. Riders may walk the courses.
- 13. There is NO TURN OUT anywhere on SSBC property, NO EXCEPTIONS.
- 14. All stallions must be handled by an adult, 18 years of age or older.
- 15. Anyone riding a horse on SSBC property MUST sign a SSBC waiver prior to mounting.
- 16. SHOW GROUNDS are OPEN 5:00pm-7:00pm on Friday and 7:00am on Saturday.
