PROGRAM GUIDELINES

- 3) YOUTH IS 18 OF AGE OR YOUNGER EXCEPTION:
THE APPLICANT HAS TURNED 18 DURING THE APPLYING YEAR.
- 4) YOUTH HAS PERFORMED AT LEAST 10 HOURS OF VOLUNTEER TIME TO SSBC.
- 5) FUNDS WILL BE MADE PAYABLE TO THE EVENT AND RETURNED TO THE MEMBER TO SUBMIT WITH THEIR REGISTRATION.
